



## APPLICATION OVER 23-YEARS-OLD

### (Single phase)

- **Application Period (Candidates admitted to the special Access Exams):**  
For the 2019/2020 school year, it runs from August 5th to 9th, 2019.
- **Enrolment:**  
September, 2019 – Deadlines are posted for the 1st phase of the national contest for access to higher education.

### Studies:

- Integrated Master in Architecture;
- Integrated Master in Architecture, specialization in Interiors and Building Rehabilitation;
- Licenciatura Degree in Design;
- Licenciatura Degree in Fashion Design.

### Candidates:

Individuals may apply to the exams that assess the capacity for higher education attendance by persons over 23 years of age—hereinafter referred to as Special Access Exams—who are over the age of 23 years-old, or who complete that age by December 31st of the year preceding the exams, provided that they fulfil the following conditions, cumulatively:

- a) They do not have access qualification for the intended course, and by 'access qualification' we mean:
  1. Having a high school study diploma or equivalent;
  2. Having approval in the national exams constituted as admission exams to the intended study, in the year in which the application is submitted or in the immediately preceding two years.
- b) If they are not nationals of a Member State of the European Union, nor are they family members of Portuguese nationals or nationals of a Member State of the European Union, irrespective of their nationality:
  - (I) Have legally resided uninterruptedly in Portugal for more than two years on January 1st of the year in which they intend to enter higher education, as well as the children who are legally residing with them, considering that the period of residence for study is not relevant for this purpose;
  - or (II) are beneficiaries, on January 1st of the year in which they intend to enter higher education, of equality of rights and duties granted under an international treaty granted between the Portuguese State and the State of which they are nationals.

### Required documentation:

The application process includes the following elements:

- a) Copy of the identification document (Optional) or alternatively the completion of a [personal identification declaration](#) form/Passport/Foreign Identification Document and NIF [Fiscal Identification Number];
- b) Photo;
- c) Other documents that the candidates deem relevant.

### Application method:

Applications will run from March 1<sup>st</sup> to 31<sup>st</sup>, and can be formalized [online](#) or in person at **ULisboa's** Lifelong Learning Centre [Núcleo de Formação ao Longo da Vida] between 9:00 and 16:00.
