- **Application Period:**
For the 2019/2020 school year (starting in September, 2019) it takes place during the month of **February**.
- **Dissemination of results:**
In the month following the end of the application phase (the list of candidates will be published in the Graduation Secretariat's portal [*Secretaria de Graduação*]), and all applicants will be notified by email with the result).

(2nd Phase)

- **Application Period:**
For the 2019/2020 school year (starting in September, 2019) it takes place during the month of **April**.
- **Dissemination of results:**
In the month following the end of the application phase (the list of candidates will be published in the Graduation Secretariat's portal [*Secretaria de Graduação*]), and all applicants will be notified by email with the result).

(3rd Phase)

- **Application Period:**
For the 2019/2020 school year (to begin in September, 2019) it will take place during the month of **June, 2019**. – **Extension until 14-07-2019**.
- **Dissemination of results:**
Until July 31st, 2019.

Candidates:

According to n.º 1 of Artigo 17.º do Decreto-Lei n.º 65/2018 of August 16th, the following individuals can apply for access to the cycle of studies leading to the Master's degree:

- a) Titleholders of the degree of *Licenciatura* degree or legal equivalent;
- b) Titleholders of a foreign higher academic degree conferred following a 1st cycle of studies, organized according to the principles of the Bologna Process by a State adhering to this Process;
- c) Holders of a foreign higher academic degree that is recognized as satisfying the objectives of the *Licenciatura* degree by the competent scientific body of the higher education institution where they wish to be admitted;
- d) Holders of a school, scientific or professional curriculum that is recognized as attesting to the capacity to carry out this cycle of studies by the competent scientific body of the higher education institution where they wish to be admitted.

Required documentation:

- *Curriculum Vitae* - Professional/Academic;
- Portfolio;
- Copy of the identification document (Optional), or, alternatively, filling out the [personal identification form](#)/Passport /Foreign Identification Document;
- Copy of NIF [Fiscal Identification Number];
- C Qualification Certificate [in Portuguese, *Certificado de Habilitações*] (proof of the academic degree[s]), must be endorsed by the consular service or submitted with the affixing of the Hague Apostille Convention by the competent authority of the State from which the document originates and, whenever are not issued in either Portuguese, English, French or Spanish, must be translated into one of these languages;
- Programmatic contents of the approved course units (Optional);
- Motivation letter;
- Other documents that the candidate deems relevant for the evaluation of the application (Optional);
- Proof of payment (receipt).
